- 39 Mr. DiGennaro presented draft copies of the 2018 financial report. He stated that the RIDA's

41 42	Mr. DiGennaro, along with Mr. Klimecko, discussed the draft 2020 budget. Mr. DiGennaro stated that he saw no problems with the budget.
43 44 45 46	A discussion began regarding component bank accounts after the reorganization. The question was whether to have one account for all or three separate accounts. A vote was taken regarding this issue. Vote result: majority of the trustees were in favor of a separate checking account for each component/district.

51	Discussion on RI Dental Foundation and possibility of charging them a management fee.
52 53	• A vote was taken, and it was decided that they should pay a \$400 per month fee.
54	EXECUTIVE DIRECTOR'S REPORT: Chris Klimecko. As written plus oral
55 56 57	• Mr. Klimecko announced his intention to leave the RIDA in 2020 and that he will likely stay on, with the approval of the executive committee, through the June 2020 BOT meeting.
58 59	• RIDA members that register for next year's Charter Oak meeting will be charged the CSDA member rate rather than full price.
60 61	<u>REPORT OF THE TREASURER</u> : Dr. Ward. As submitted. Chris Klimecko distributed the draft 2019 budget and provided a brief summary.

80 81	• Chris Klimecko and Christy Durant attended a meeting with Tom Coderre (senior advisor to the governor on opioid related issues) regarding Massachusetts law that

- 82 prevents out of state dentists' controlled substance prescriptions from being 83 honored by MA pharmacies.
- 84 0 We're still waiting for an answer from the governor's office regarding a delay in 85 implementation of mandatory e-Prescribing narcotics.

- 87 **<u>OLD BUSINESS</u>**: Draft component/district bylaws will be distributed during November
- 88 HOD meeting as will the new RIDA bylaws. After a lengthy discussion a vote was taken that
- a special meeting of the HOD will be called by Dr. Elson after the November meeting and
- before January 6, 2020 to allow the HOD to vote on the new proposed bylaws. Vote wasunanimous.
